

Tentative Bid Schedule for 2017 (Sept—Dec)
Carolinas Comprehensive Purchasing Consortium

Note this schedule is tentative: Invitations to Bid are posted on the web site approximately 30 days before the bid date. The bid date may vary but the sequence of product bids will follow the order listed. Please watch the bid site for Invitation to Bid Notice each month

The Carolinas Council of Housing Redevelopment and Codes Officials (CCHRCO) administer a Comprehensive Purchasing Consortium (CPC) for its members in North and South Carolina. The Consortium serves as a bidding agent and provides CCHRCO Member Agencies the bid results. Member Agencies may then use the bids and/or the specifications for purchasing bid items (supplies, materials, equipment, and services) needed in the development, operation, and maintenance of affordable housing. The CPC program is based on the CSP program formerly provided by HUD.

Sealed bids for products and services will be received and reviewed by the CPC Committee on a semi-annual bid schedule. Bid prices of qualified bidders must be guaranteed for six months from the bid date (to the date of the next semi-annual bid). Bids will be posted on the World Wide Web at CPC-CCHRCO.org (a secure site) for voluntary use by member agencies. Bidders of installed products must be licensed contractors in both states and show proof of capability to furnish performance and payment bonds.

Bid packages are available approximately thirty days prior to bid date on the CPC website. The bid package is also available by email in Microsoft Word format, upon request.

Passwords will be assigned upon request of vendor and remain valid through the bid cycle. A vendor's access will be removed if no bid is submitted during any of the bids items during a six month bid cycle.

Bids for all product bids will be closed at 10:30 a.m. on the bid date and opened in the same order as listed on the invitation to bid. This is a public bid opening and bidding vendors are encouraged to attend.
